


This is how one can run an illegal empire.

But the jewel of all jewels to compromise...



- 3/ Now, mobsters love to talk about the judges they have in their pockets. Most of mob history is oral and full of gossip & conspiracy. But there are key individuals, & their intersection w/judges they may have compromised is discoverable if you track them carefully...
- 4/ Like this shi*tbird, from early 20th century: SAM INSULL.

Chicago knows him well. And he bought himself some judges.

Street habitues to make the exodus to Lawndale. ²³ Insull, a former private secretary to inventor Thomas Edison, and himself a genius in business, inherited Edison's General Electric power company and, thanks to massive political corruption, built it and his other holdings into a \$2 billion empire. The Rosenbergs, in exchange for uncontested junk-hauling contracts from Insull, corrupted countless pols who happily allowed Insull to use monopolistic and predatory practices in exchange for "investment opportunities" in the power company—in other words, insider stock priced far below the market quotes. Ovid Demaris, the seminal historian of Chicago crime, described the unsavory climate thus: "[Insull] built his paper colossus on the hot coals of corruption. Corrupt politicians and predatory law firms kept it precariously fireproof for forty years in a continuing conspiracy that provided low taxes, and favorable legislation, plus safe judges, reasonable mayors, pliable aldermen, patronage officeholders, and

anybody else who could serve Insull's undivided interest."24

Everyone got rich together, and when the stock market crashed in 1929, Insull merely sold overvalued stock to the public, costing investors over \$2 billion in losses. So hated did Insull become that he hired Capone's musclemen to protect him from his countless enemies. Eventually, Insull's paper profits evaporated and he was charged with stock fraud and, separately, with embezzlement—he escaped conviction in both. ²⁵ Years later Moe Rosenberg would serve a prison term for receiving stolen goods and was also indicted for tax evasion. In an effort to lessen his sentence, Rosenberg gave a full confession in 1933 regarding the massive political-corruption schemes he had entered into with Insull. However, Rosenberg died before the trial started, and a year later his sealed confession was made public. ²⁶

that was fraudulent, stolen," asserted William Gallinaro, a senior investigator for the Senate Subcommittee on Investigations. Rebozo avoided prison and never faced trial. Under ordinary circumstances, federal law requires a fine of up to \$10,000 or a prison term up to ten years, or both, for anyone who knowingly takes part in such deals. Eventually, a civil case involving Rebozo and the sale of the

Rebozo's mob-friendly bank was also a suspected pipeline for Syndicate money skimmed from an opulent gambling casino in the Bahamas. Operated by Nixon and Rebozo buddy James Crosby (who contributed \$100,000 to Nixon for the 1968 primaries), the Paradise Island Casino was linked to top U.S. mobsters. Despite Life magazine's report that Crosby's casino would be run by "Lansky & Co.," Nixon showed up as the star attraction at its opening party, on January 7, 1968, where he was photographed with Crosby. At the 1968 Republican convention in Miami Beach, Nixon accepted the use of a luxurious yacht owned by Crosby's casino.

By the 1960s, FBI agents keeping track of the Mafia had identified Bebe Rebozo as a "non-member associate of organized crime figures." Former Mafia consigliere Bill Bonanno—the son of legendary New York godfather Joe Bonanno—asserts that Nixon "would never have gotten anywhere" without his old Mob allegiances. And he reports that, through Rebozo, Nixon "did business for years with people in [Florida Mafia boss Santos] Trafficante's Family, profiting from real estate deals, arranging for casino licensing, covert funding for anti-Castro activities, and so forth." ##

When Prohibition ended 79 years ago, California replaced the bootleg liquor trade with a legal monopoly – a series of laws that locked in industry marketing practices and enforced industry established retail prices.

The misnamed "fair trade" laws were the handiwork of the Capitol's dominant lobbyist of the era, Artie Samish, who later described it this way in his autobiography:

"Only by regulation and enforcement could the alcoholic beverage business thrive and prosper. Cutthroat competition could have been ruinous. So I put through fair-trade laws to protect wholesalers, distributors and retailers. All of them make a profit in California, and they always have."

Samish went to prison for treating the Legislature like a puppet (he was once photographed holding a ventriloquist's dummy he named "Mr. Legislature"). But his laws remained on the books for decades, until the courts struck down price-fixing.

The biggest effect the Kefauver committee had in southern California was to start a chain reaction against petty crime. The police have been particularly active in driving prostitutes from the more accessible, and cheaper, locations

The world's oldest profession has found it very hard going in the Hollywood hills and many of the girls have trooped over the line into Las Vegas, Nev. Bookmakers too are suffering. A year ago you could place a bet in almost any neighborhood. Now it is hard to reach a "book" even if you do know his telephone number. One example of the zeal shown by Los Angeles police in chasing down gamblers was the boarding of 12 fishing boats which were equipped with slot machines. Kefauver hit again and again at the narcotics trade when he was in California. On the surface at least the police seem to have taken him seriously and tightened up. OPINION

Thompson, J.

This is a petition for a writ of prohibition to restrain the grand jury and the prosecuting officers of Sacramento County from obtaining possession by subpoena or otherwise of copies of petitioner's income tax statements for the years 1935, 1936 and 1937, and from compelling a disclosure of the contents thereof, the originals of which are filed with the state and federal governments for taxation purposes. These copies are sought to be used by the grand jury as evidence in its investigation of alleged lobbying and bribery of members of the state legislature. The respondents have demurred to the petition, and also filed an answer denying the material allegations thereof.



After graduation, Mr. Kennedy joined a law firm in San Francisco, and in 1963 married Mary Jeanne Davis, who now teaches elementary school in Sacramento. That year was a turning point in the young lawyer's life. His father died of a heart attack, leaving his personal financial affairs in extraordinary disarray. The son returned to Sacramento, sacrificing a potentially lucrative practice in San Francisco, to take over his father's solo practice and help the family.


